Allo stesso modo, la proprietà di essere colorato di blu è accidentale alla figura del quadrato. Le proprietà essenziali sono quelle che definiscono la natura della figura, mentre le proprietà accidentali sono quelle che possono variare senza alterare la natura della figura.
